Large Grants Fund

Six applications were reviewed:

- 1. Age UK Exeter
- 2. Topsham Adventure Centre
- 3. Food Action Exeter
- 4. Hospiscare
- 5. Topsham Cricket Club
- 6. ISCA Enterprise

This funding is to support building or refurbishment costs or the purchase of equipment. Groups need to demonstrate a minimum of 50% match funding (unless in a priority community).

The Large Grants Budget for the current financial year is £60,000.

In previous rounds £20,000 has been awarded to the Islamic Cultural Centre Exeter, Positive Light's and St Sidwell's Community Centre, plus £10,000 was committed to the Whipton Community Association subject to proof of match funding. £12,000 was awarded in current round. We have £18,000 remaining for the 3rd round later in the year.

Community Buildings Fund

Community Organisations can apply for a maximum of £5,000. The aim of the funding is to help Community Organisations with their financial planning. This fund is to contribute to the everyday running costs of community centers such as wages, utility bills, rent etc.

- £80,000 available (this is the April 2020 March 2023 budget covering 3 financial years)
- £42,000 committed in "legacy" 3-year grants going back to April 2020
- £15,000 awarded in 2021/22
- £12,000 awarded so far this year (2022/23)
- £11,000 is therefore available for 2022/23

Out of the £11,000 budget for the current round, £5,000 was awarded to the Stoke Hill Community Association;

remaining budget = £6,000

Small Grants Fund

The Exeter Small Grants Fund will support groups and organisations with a one-off grant of up to £2,000 to help run events, festivals and projects that aim to encourage community participation.

This fund can also be used for a one-off purchase or repair of equipment.

Awards will be for a maximum of 80% of the funding target. Applications reviewed on a monthly basis, with no closing date.

£50,000 available; £22,315 was already awarded in the first few rounds; so £27,685 was available for the current round. We awarded £6,000 in the current round, therefore £21,685 is available for the next round.

3. Proposals for funding for Cost Of Living pressures

Cllr Pearce introduced the proposal to be able to offer a ring-fenced budget of £10,000 to offer community centers and other community based organisations the opportunity to apply for a grant up to £500 to help support increased energy costs over the winter. This would be based on the center's offering or promoting 'warm spaces' for local people to meet to join existing activities or just to meet to enjoy company and a warm space.



The suggestion is that £6,000 is reserved from the Community Buildings Fund, and £4,000 reserved from the Small Grants budget, giving a £10,000 budget as part of the COL fund. This would be supplemented by Ward grants where groups can continue to apply for a ward grant up to £350 to support additional costs over the winter.

The panel gave support for this proposal.
